



Happy Summer 2022 Everyone!

Part of your Lake District Board's duties is to become educated on best practices for healthy lakes and to pass these best practices on to you. Here are a few of those best practices:

-You might be seeing filamentous algae on the surface by your shoreline Not to be confused with curly leaf pondweed. The best practice is to rake it out. The WDNR does not want it to be chemically treated.

-Aquathrusters near your dock do not help the lake. It only re-suspends sediment to other parts of lake and to your neighbors.

-The Clean Boats Clean Waters volunteer hours are at about 75. 25 more hours are needed before the end of October. Sign up with Kim Swenson. Thank you for your time if you have worked the

landing this year.

-The lake has been treated for curly leaf pondweed in the years 2018-2021. In 2022 no treatment occurred. This was intentional so that the native plant population could be evaluated and data could be collected. There are plans to treat the lake again in 2023. Remember, native plants are a good sign of a healthy lake.

-Refrain from using phosphorus on your lawn, as runoff into the lake occurs. Area farmers use best practices as well to avoid harming the watershed and the lake.

-Raking your shoreline is like a machine harvester. You are taking out the turions (seeds) that drop to the lake bottom and grow.

My Commissioner term is ending and I plan to hand off my duties to another lake resident. (Let me know if you have an interest!) It has been an educational experience and so fun meeting and getting to know all of the residents on the lake. It was my privilege to work with Sharon Dunemann (past Board Member), Carol Timmerman, John Vono and Dan Stoffel (past Board Member), all of whom have a vested interest in making our lake the best it can be. It was great working with Jim Gores (Barron County Board Rep) and Ken Schepps (Almena Township Board Rep). Thank you. See you on the lake, at our social events, or working the landing.
