#### **CBCW**

The Upper Turtle Lake District will be sponsoring a Clean Boats, Clean Waters (CBCW) project again this year at the Upper Turtle Lake public boat landing. The initiative is currently in a holding pattern to avoid face-to-face inspections.

As a review, CBCW includes teams of volunteers as well as paid staff, who perform boat and trailer checks, disseminate informational brochures and educate boaters on the prevention steps to stop the spread of Aquatic Invasive Species (AIS). These steps include:

**Inspect** your boat, trailer and equipment.

Remove all attached plants or animals.

**Sale:** Friday and Saturday, August 21<sup>st</sup> and 22<sup>nd</sup>. More information on page 3. **Drain** all water from boats, motors, live wells and other equipment.

**Never** move live fish away from a waterbody.

Dispose of unwanted bait.

**Buy** minnows from a Wisconsin bait dealer and use leftover minnows only if used on the same body of water or if no lake water or other fish were added to the container.

Following these steps also helps boaters comply with Wisconsin state law, which prohibits the transport of aquatic invasive species.

In 2018 there were 285 boats inspected, with 564 people contacted and 248 hours spent on boat inspections. (81 paid, 167 volunteer). In 2019 there were 307 boats inspected, 572 people contacted and 222 hours spent inspecting boats (81 paid, 141 volunteer). 46% of the boats inspected reported prior encounters with CBCW volunteers.

Once things return to some semblance of order, the DNR will be contacted to set up a CBCW training. We will be making a plea for volunteers when we learn it is safe to begin inspections. Please consider donating some time! Watch the UTLD Facebook and website pages for updates.

## Independence Day Boat Parade

Everyone looks forward to this popular summer event! Parade participants should meet near the island at 1:00 p.m., and follow the Lake District Pace Boat around the lake. The Pace Boat will have the Lake District banner prominently displayed. Who can take the 2020 trophies? The Studnicka family has taken home the "Most Creative" trophy three years in a row, can they be unseated? Trophies for "Most Creative" and "Most Patriotic" decorated watercraft will be awarded at undisclosed lake locations. Be mindful of boats that don't want to be bombarded with water balloons. #### Free Trees!

The Upper Turtle Lake District purchased 350 trees to give away to landowners within the District. The trees will be distributed on Saturday, May 9<sup>th</sup>, 2020, 10:00 a.m. – 12:00 p.m. at the Boat Landing. Four year old bare root transplants of Norway Pine, White Spruce, Red Oak, Serviceberry, and Red Maple were purchased. If you can use some trees, stop down and pick them up. We expect the trees will go quickly. Social Distancing Measures will be practiced. Drive up, stay in your car, and the trees will be put in your trunk or truck box.



# Notice: 2020 CLP Management and Treatment Plan

Based upon the studies completed in 2019 and 2020, the Lake District and its Lake consultants have developed a 2020 CLP treatment plan that will begin this spring. The treatment plan targets the same areas as in 2019. (See map on the next page, the treatment areas are highlighted in green.) As you may remember, CLP is a cold water, early season aquatic invasive species that begins its growth cycle under the ice.

This serves as notice, as specified per Chapter NR 107, WI Administrative Code; of intention to treat approximately 74.09 acres in Upper Turtle Lake with aquatic pesticides to control the nuisance exotic aquatic vegetation curly leaf pondweed (CLP). Northern Aquatic Services of Dresser, WI will complete the proposed treatment during the spring of 2020, sometime between now and late May, depending on weather conditions.

Additional information including maps and a copy of the permit application can be found at the Lake District's website and on the website of Lake Education and Planning Services, LLC at <a href="www.leapsllc.com">www.leapsllc.com</a> Lake Education and Planning Services, the consultant working with the Lake District will conduct a public informational meeting on the proposed treatment if five or more individuals, organizations, special units of government, or local units of government request one. Any request for a public meeting on this treatment must be made within five days after this notice is published. The request must specify the topics to be discussed at the meeting, including problems and alternatives, and must be sent to: Lake Education and Planning Services, 302 21 1/4 St, Chetek, WI 54728 and to the WDNR, 810 W. Maple Street, Spooner WI 54801.
